| PUA<br>Pandemic Unemployment<br>Assistance | 01/27/2020 thru 12/31/2020 | <ul> <li>up to 39 weeks of benefits to individuals who are <ol> <li>self-employed</li> <li>seeking part-time employment</li> <li>without sufficient work history</li> <li>Persons who have exhausted all rights to regular UC benefits, PEUC, etc.</li> <li>Persons who otherwise would not qualify for regular UC benefits, PEUC, etc.</li> <li>Min./Max. Benefit: \$107/\$247 (may be elig for \$600 weekly federal benefit)</li> <li>Unemployment must be related to COVID-19: Applicants must <i>self-certify</i>: <ol> <li>partially or fully unemployed, OR</li> <li>unable and unavailable to work because of one of the following circumstances: <ol> <li>They have been diagnosed with COVID-19 or have symptoms of it and are seeking diagnosis;</li> <li>A member of their household has been diagnosed with COVID-19;</li> <li>They are providing care for someone diagnosed with COVID-19;</li> <li>They are providing care for a child or other household member who can't attend school or work because it is closed due to COVID-19;</li> <li>They are quarantined or have been advised by a health care provider to self-quarantine;</li> <li>They were scheduled to start employment and do not have a job or cannot reach their place of employment as a result of a COVID-19;</li> <li>They have become the breadwinner for a household because the head of household has died as a direct result of COVID-19;</li> <li>They have to employment is closed as a direct result of COVID-19;</li> </ol> </li> </ol></li></ol></li></ul> |

| PUA PUC Pandemic Unemployment Compensation                        | thru 07/31/2020       | <ul> <li>Not available for individuals who:         <ul> <li>have the ability to telework with pay</li> <li>are receiving paid sick leave or paid leave benefits.</li> <li>BUT: paid sick leave or other paid leave benefits are less that your usual work week, may still be eligible.</li> </ul> </li> <li>Additional \$600 weekly federal benefit <i>Eligibility</i>: individuals who are collecting regular UC, PEUC, PUA, etc.</li> </ul>   |

| <b>PEUC</b><br>Pandemic Emergency<br>Unemployment<br>Compensation | thru 12/31/2020       | <ul> <li>up to 13 weeks of benefits and</li> <li>La. Benefits – 26 weeks</li> <li>Weekly benefit amount: regular compensation + \$600</li> <li>Eligibility: individuals who <ol> <li>have exhausted all rights to regular UC benefits or federal law;</li> <li>No regular comp avail b/c you've received all available based on employment/wages for the base period.</li> </ol> </li> <li>Rights terminated by reason of the expiration of the benefit year with respect to which the rights existed.</li> <li>have no rights to regular UC under any other state or federal law;</li> <li>Able to work, available to work, and actively seeking work.</li> </ul> |
